

If you honestly and accurately admit your own mistakes in the relationship, this can help establish your credibility. It also helps establish your credibility if you point out objectively positive traits of the respondent insofar as possible. Petitioners who describe themselves in only positive terms and the respondent only in negative terms often hurt their own credibility because they do not seem realistic. So please be as objective and factual as possible.

The purpose of these questions is to help the judge set grounds for nullity. Once the grounds are set, then you will be asked to complete a questionnaire and/or have a hearing with the judge that focuses specifically on the grounds being considered for the cause.


Why does this process take so long?
